**BE IT RESOLVED THAT:**

1. It is hereby determined that sufficient monies are now on hand for the payment of principal and interest to come due during the year 2022 for the City of Waite Park Taxable General Obligation Bonds, Series 2018A.
2. The County Auditor of Stearns County is hereby authorized and directed, pursuant to the provision of Section 475.61, Minnesota Statutes Annotated, to cancel the levies for said indebtedness heretofore made to be levied for the year 2021 for collection in the year 2022 as follows:

Tax Abatement Levy	\$290,000
Debt Service Levy	<u>187,068</u>
Total	\$477,068

3. The bond and interest hereinabove is the actual amount requested to be spread upon the tax rolls and any increase or decrease is a result of a deficit or surplus in a particular bond fund.

- 5. The City Administrator-Clerk-Treasurer is hereby instructed to transmit a certified copy of this resolution to the Stearns County Auditor.
